AFFIDAVIT

BEFORE ME, the undersigned Notary Public, personally came and appeared, Jason M. DeCuir, who was a candidate for State Senate, East Baton Rouge Parish, District 14, in the year 2007 who, after being duly sworn, did depose and say that:

During the course of the campaign I (Jason DeCuir) loaned my campaign forty thousand dollars (\$40,000.00) from my personal funds and said loan was recorded on Schedule B-1 of the candidate's report. At the conclusion of the campaign and the disbursement of expenditures in 2008, my campaign had no remaining funds and the balance of the loan made to myself, which was thirty-three thousand dollars (\$33,000.00), was forgiven by me. As can be seen from my campaign disclosure and the campaign reports, there was no money remaining in my campaign. My account was closed and there has been no attempt to raise any money or conduct any activity since the filing of my last campaign report in 2008. Unfortunately, Schedule B showing that the loan was forgiven was not filed with my last campaign report.
