This form is used to report payments by the candidate or his political party (1) for advertising that is broadcast or published on election day (2) for the services of election day workers, and (3) to organizational activities in support of the candidate. NOTE: This report is required **in addition** to all other required reports. Therefore, the information reported on this report must be reported in subsequent "Candidate's Reports" for this election.
