INSTRUCTIONS

- Return form to: Office of the Clerk, P. O. Box 44281, Capitol Station, Baton Rouge, LA 70804-4281.
- Income which must be reported is limited to that received directly from the state or political subdivisions of the state in excess of \$250.00 and income related to services performed for or in connection with a gaming interest received by a member, a member's spouse, or a business enterprise in which the member or the member's spouse owns at least 10%.
- Income from service in the legislature, salary from full time employment of a member's spouse, salary of a member's spouse when such spouse is an elected official, and benefits from a statewide public retirement system are excluded and should not be reported.
- If no such income is received, Item No. 4 below should be checked and the form signed on the reverse side. If any such income is received, Items No. 5 and/or 6 should be completed.
- Each separate agency, department, or political subdivision from which income has been received should be listed separately. Also, income which may be received from the same or different agencies, departments, or subdivisions, but which was payable to different income sources (e.g., two different corporations) should be listed separately.
- This form should be completed with respect to income received during calendar year 1998 only; and, if applicable, only during the period in which legislative office was held.


