This form is used to report payments by the candidate or his political committee: (1) for advertising that is broadcast or published on election day; (2) for the services of election day workers; and (3) to organizations for election day activities in support of the candidate. NOTE: This report is required in addition to all other required reports. Therefore, the expenditures reported on this report must be reported in subsequent "Candidate's Reports" for this election.
