Any committee which realizes that it will have over \$500 of financial activity after January 31 must registrate the days of its realization of that fact. However, if this occurs during the ten day period prior to an election the Statemer Organization must be filed within three days.

Political committees must file reports of receipts and disbursements on an annual basis. Annual reports are due by Febr. 15 and should cover the preceding calendar year. Also, committees must file reports of receipts and disbursements on the sa schedule as the candidates it supports or opposes. Reports are also due in connection with propositions (ballot issues) committee supports or opposes.
