Enclosed please find amended pages from the 10G, 40G and Supplemental Reports for Karen Barnes for 1998. Also enclosed is the amended Supplemental Report for 1999. The previously filed reports contained several mathematical errors as well as some incomplete description information on the Schedule E-1. Along with the prior discrepancies noted, there were also loan repayments inaccurately reported. Details of all changes made to the reports are as follows:

10G Report 9/23/98 through 10/14/98:

1. The original dates stated for this report (9-14-98 through 10-24-98) were incorrect.
2. Funds on hand at the beginning of period were incorrectly stated.
3. Two contributions and four expenditures were erroneously included on this report because the dates of the reporting period were incorrectly entered. The overlapping time period caused several duplications. These contributions and expenditures were removed from this report, but remain on the 10P Report filed.
4. Loans which were originally shown to be paid on the Schedule B were found not to be paid. The schedules were changed to show that payment had not been made on these loans. No loan payments were indicated on the Summary page of the originally filed report. This change does not affect the loan balances stated.
5. Total amount of contributions and expenditures on Summary pages as well as total of funds on hand at the close of reporting period were changed to reflect the revisions to the A-1 and B-1 schedules.
