**LEGISLATOR'S DISCLOSURE  
 IN CONNECTION WITH A PUBLIC SPEECH  
 OUTSIDE THE STATE OF LOUISIANA**

The Code of Governmental Ethics, pursuant to the exception in La. R.S. 42:1123(16), allows a legislator to accept food, refreshments, lodging, and/or reasonable transportation related to making a **public speech**<sup>1</sup>, provided the public speech is given in any state, territory, or commonwealth of the United States or any country in North America, the territorial waters of Louisiana, or any offshore structure located on the outer continental shelf seaward of such territorial waters and offshore of Louisiana.

Each legislator who makes a public speech **OUTSIDE OF THE STATE OF LOUISIANA** shall file a completed Form 420 disclosure **WITHIN 60 DAYS OF MAKING SUCH SPEECH**.
